WHEREAS, the Annual Budget for the Borough of Jamesburg Fire District No. 1 for the fiscal year beginning January 1, 2014 and ending December 31, 2014 has been presented before the Board of Commissioners of the Fire District No. 1 at its open public meeting of Tuesday, December 17, 2013; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.),

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$554,809, which includes amount to be raised by taxation of \$439,944, and Total Appropriations of \$554,809; and


WHEREAS, the amount to be raised by taxation to support the district budget, shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 1 has taken into account the assessed valuation of taxable property in the Fire District No. 1,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District No. 1, at an open public meeting held on December 17, 2013, that the Annual Budget, including appended Supplemental Schedules, of the Borough of Jamesburg Fire District No. 1 for the fiscal year beginning January 1, 2014 and ending December 31, 2014 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No. 1 's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Borough of Jamesburg Fire District No. 1 will consider the Annual Budget for adoption on January 16, 2014.

FISCAL YEAR: From January 1, 2014 to December 31, 2014

1. Complete a brief statement on the 2014 proposed Annual Budget and make comparison to the current year's adopted budget. Explain significant increases or decreases, if any.

The 2014 Operating revenues are \$479,809 compared to \$470,955 in 2013. The overall expenditure plan has increased \$8,854 from \$470,955. The increase overall in expenditures is caused by the net effect a provision for additional debt service, additional insurance offset by a decrease in LOSAP.

2. Complete a brief statement describing the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unreserved Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. **If unreserved fund balance is reduced by more than 10%, explain the projected impact on the following year's budget.**

Amount to be raised by taxation in 2014 is \$439,944 compared to 2013 of \$416,944. The tax rate in 2014 is .186 (18.6¢) per \$100 assessed valuation vs. .177 (17.7¢) per \$100 assessed valuation in 2013. Unrestricted surplus utilized in 2014 of \$39,865 compared to 2013 of \$54,011 is lower primarily due to the need to offset increases in expenses with the tax levy increase and to maintain a balanced budget.

3. Include a statement explaining how the District is complying with the Property Tax Levy Cap. The statement must explain reasons for exceeding the Levy Cap and identify the appropriations that caused the district to exceed the Levy Cap, and how they are being addressed by a referendum.

The Fire District's 2014 amount to be raised by taxation is in compliance with existing Property Tax Levy Cap.

4. If the District plans to pass a Resolution for the Release of Restricted Fund Balance, explain the reason and purposes of the appropriation

The amount of \$10,000 is being appropriated to the reserve for future capital outlay. An average residential unit with an assessed valuation of \$123,800 will pay \$230.26 in 2014, an increase of \$11.14.
