The 2018 Operating Revenues are \$463,000 compared to \$727,350 in 2017. The majority of the decrease represents a reduction in the use of fund balance in 2017 to provide for Capital Projects previously voter approved (see F-5). The basic operating expenditure plan is \$410,350 from \$402,350, an increase of \$8,000. The increase overall of operating expenditures is caused by an increase in debt service.

Amount to be raised by taxation in 2018 is \$463,000 which is the same as in 2017. The proposed tax rate in 2018 is .197 (19.7¢) per \$100 assessed valuation is the same as in 2017. Unrestricted surplus utilized in 2018 of \$None compared to 2017 of \$264,350 is lower due to the need in 2017 to supplement funding for voter approval Capital Projects in 2017 not recurring in 2018.
